## **AREAS OF SPECIAL INTEREST**

Health Disparities. Addressing structural and systemic bias in institutions of power in the US as a public health threat. Taking an historical, Indigenous view of white privilege, through social construction and narrative theories, to identify where and how systemic bias is embedded in policies and procedures to ensure that disparities remain and how implicit bias is created within the structural and systemic narrative to form a feedback loop in support of continued disparities.

Community Relationships: Building respectful bridges between non-dominant cultures and research that honors the voice, traditions and beliefs of people. Creating an open cultural space for the community's voice to define and address their issues in their own way, with the onus on the researcher to keep that voice whole and valid while helping communities to find answers.

Translational Science: Understanding how white privilege is reflected in our current view of translational science, our research domain criteria, including the RDoC and the implications of this for continuing health disparities despite our "best efforts".

Substance Use, HIV-risk, Antisocial and Depressive Behavior: Contribution of culture in academic and family environments that protect children from substance use, HIV-risk, antisocial

and depressive symptomatology. To highlight the strength within Indigenous and Black communities and remove the “deficit view” from research to acknowledge the protective nature of this cultural strength.

Education: Procedures for assessing meaningful change in student performance within longitudinal designs; conceptual and assessment models of early literacy and school success that honor non-dominant culture student achievement; methodologies for identifying exemplary learning environments for all students; focusing on curriculum content when developing educational equity models.

Research Methodology: Social validity and treatment utility of prevention and intervention strategies; hypothesis validity in contemporary research; decolonizing research methods to increase trust within non-dominant culture communities; and the complexities involved in conducting basic research in applied settings.

Statistics: Honoring the story contained within data for non-majority cultures; how mainstream statistical approaches can silence this story.
